

# COMMUNITY SERVICE REPORTING DASHBOARD INFORMATIONAL GUIDE

# Department/District/Post Administrative Operations Status



Just to give you a quick information on what are the Columns represented in our Department of Pacific Areas Dashboard and what are the requirements:

The DPA Dashboard consisting of the Post and Location, Good Standing, Buddy Poppies, Programs, Membership and Qualifications.

a. LOCATON: This Column provides you with Districts Number, Post Number, Name and Location

# b. GOOD STANDING:

- ELECTION REPORT: This is a yearly submittal of your Post Election Report to National it should be submitted on or before June 1 the following after the Post-Election.
- QUARTERMASTER BOND: Post Quartermasters in accordance with National By Laws needs to be Bonded and documents needs to be sent and coordinated with our DPA QM.

- SCHOOL OF INTRUCTION: This requirement is done on Post level and is a requirement for all Post Officers conduct their Training especially the newly Elected Officers. Once Training is conducted you need to notify the Department that you have conducted this Training with complete documentation, sign up lists, pictures etc.
- SERVICE OFFICER TRAINING: This training is essential for new Post Service
   Officers once you conducted the training provide all documentation to DPA
   Service Officer for accreditation.
- IRS 990: This requirement is for Post who are to report such matters to the Internal Revenue Service. IRS Form 990 is an informational tax form that most tax-exempt organizations must file annually. In a nutshell, the form gives the IRS an overview of the organization's activities, governance and detailed financial information. Form 990 also includes a section for the organization to outline its accomplishments in the previous year to justify maintaining its tax-exempt status.
- INSPECTION STATUS: This column is for our DPA Inspector to validate if the Post Inspection has been MET or UNMET by each Posts.
- AUDITS: This column is for our DPA Inspector to validate that Post conducted their Audits IAW National By-Laws.
- DONATION TO PROGRAMS: This column certifies that Posts donated to VFW National Programs Veteran & Military Support, UNMET Needs and so on.
- DONATION TO NATION HOME: This column is for Posts to have donated monies to our National Home for Children in Eaton Rapids, Michigan. Once Post donation is sent, the Post Commander or Post Adjutant should notify the National Home Chairman and he will mark you as MET.

### c. POPPIES:

- BUDDY POPPY GOAL: This column is automatically populated with each Post Goal of Buddy Poppies which are to be sold.
- BUDDY POPPY ORDERED: Posts are required to purchase Buddy Poppies for their Post and coordination needs to be done with DPA Quartermaster.
- BUDDY POPPY DRIVE: Each Posts should conduct a Poppy Drive in their respective areas and once it's conducted, Post Commander or Post Adjutant should contact the DPA QM so he can annotate you as having MET the requirement.


### d. PROGRAMS:

- VOICE OF DEMOCRACY: All Posts are required to participate in in VOD yearly and once you have MET the requirement the Voice of Democracy Chairman will be responsible to update this column.
- PATRIOTS PEN: All Posts are required to participate in in Patriots Pen yearly and once you have MET the requirement the DPA Program Manager will be responsible to update this column.
- LE/FF/EMT: This program is for the Law Enforcement, Firefighters, Emergency Medical Technician Awards Program run by our DPA Safety Chairman. Every year we award the most outstanding LE/FF/EMT in the Pacific Areas.
- TEACHER: This program is for the most outstanding Teacher in the Department of Pacific Areas and once the Posts submits their nominees to the Program Manager, he or she will update the Dashboard accordingly. This year VFW National made it as optional requirement in order to make ALL STATE.
- ACTION CORP PROGRAM: This program is for Posts to sign up VFW members, relatives and friends of the VFW to the Action Corp weekly. Once you have MET this requirement you need to notify the DPA Action Corp Program Manager that you have fulfilled this requirement.
- PARTNERING EVENTS: This is new requirement from VFW National that each Post are required to partner with 2 Organizations like Burger King or Sports Clip or in our case we are located overseas, you can partner with some of these Non-profit Organizations (i.e., Rotary Club, Lions Club, Freemasons, local Red Cross Chapter, Jaycees International etc.) to conduct relief efforts, hospital events and other activities. You need to provide documentation like pictures, newspapers clippings.
- SOCIAL MEDIA: This is a new requirement as well; each Post are to conduct their Social Media presence by creating their Post Facebook Accounts and promote their Post Activities as well as VFW National programs in their FB Accounts. Once these is established you need to inform DPA that you have MET this requirement.

## e. COMMUNITY SERVICE REPORTING:

This Community Activities Reporting Program is done via the CSR Program Database under the Members Only Section. Each Posts are required to do their CSRs monthly and a new VFW National requirement of a 10% increase to challenge all Posts from previous Fiscal Year 2020-2021. All Posts are encouraged to do their Community Activities Report their daily and to do this is to contact your Post JVC. Each

Community Activity consists of the following, Community Service, Veteran Assistance, Legislative Advocacy, Youth Development.

- F). MEMBERSHIP: This column represents Post Membership information, and which are essential to make ALL STATE or ALL AMERICAN.
  - MEMEBERSHIP AS OF JUNE 21,2021: This column is populated automatically with the information provided by Membership National.
  - DIVISION: This column is automatically populated by VFW National base on Post Membership statistics from last Fiscal Year.
  - GOAL REACH: This column is annotated if you have reached your Post Membership goal for the current year.
  - ALL STATE QUALIFIED: This column the SVC of Department of Pacific Areas will annotate if Post have MET the All-State requirements.
  - AL STATE ORDER PLACE: This column the DPA SVC will annotate if ALL STATE awards were ordered.

- ALL AMERICAN QUALIFIED: This column the DPA SVC will annotate if Post are considered for ALL AMERICAN.
